EXECUTIVE SUMMARY

The Puffer/ABFM Fellowship at the National Academy of Medicine (NAM) celebrates fifteen years of cultivating leaders in family medicine and health policy. Established to strengthen family medicine's voice in national health reform, the Puffer/ABFM Fellowship provides early- to mid-career physicians and scientists the opportunity to participate directly in the NAM's influential work. Fellows contribute to the development of national reports, consensus studies, and policy recommendations that shape the future of health care delivery, equity, and public health.

Recognizing “the foundational importance of family physicians providing comprehensive, sustainable, and high-value health care,” ABFM created the Fellowship to ensure that the discipline's leaders could shape national reform with insight drawn from real-world practice and community health. From inception, ABFM viewed the Puffer/ABFM Fellowship as a means to prepare scholars who could “understand relevant problems, imagine plausible solutions, and forge alliances and partnerships sufficient to solve them,” reflecting the Board's long-term vision for leadership development.

The Puffer/ABFM Fellowship's location within the NAM offers a uniquely rich environment. Fellows gain “first-hand knowledge of the social, economic, and political forces affecting health status and health care delivery,” and they engage with “the most eminent researchers, policy experts, and clinicians” who develop nonpartisan, evidence-based guidance for pol-

icymakers. The NAM's explicit goal for its early-career fellowships, “to prepare young investigators to influence the future of health care throughout their careers and accelerate their own career development,” is core to the Puffer/ABFM Fellowship's impact.

Over fifteen years, the Puffer/ABFM Fellowship has expanded in size, diversity, and visibility. Fellows now serve across an array of activities at the NAM and the National Academies of Sciences, Engineering, and Medicine, influencing topics ranging from primary care transformation and workforce sustainability to digital health, maternal health, and health equity. Their contributions reflect the NAM's longstanding experience in “building consensus among academics and transforming that consensus into politically viable proposals,” a skillset Fellows help bring back into family medicine and primary care research.

Looking ahead, the Puffer/ABFM Fellowship is poised to deepen its strategic role. With strengthened mentorship, greater cross-program alignment, and growing collaborative work between ABFM and the NAM, the program remains central to developing leaders who can bridge clinical practice, scholarship, and national policy. As the NAM has historically seen its fellowship alumni advance to roles as deans, public agency leaders, and national policy advisors, the Puffer/ABFM Fellows continue that trajectory—advancing the influence of family medicine in shaping a better health system for all communities.

INTRODUCTION

The American Board of Family Medicine (ABFM) recognized that primary care voices remain vastly under-represented in national policy and systems leadership. As ABFM notes, our specialty is confronting “greater complexity or more rapid transformation of the health care delivery system than at any time in its history.” Thus, through partnership with the ABFM Foundation and the National Academy of Medicine (NAM), the Puffer/ABFM Fellowship at the NAM was established in 2010 to advance the next generation of family medicine leaders in health policy, bridging the worlds of clinical practice, research, and national decision-making.

Named in honor of Dr. James C. Puffer, former President and CEO of the ABFM, the Puffer/ABFM Fellowship provides early- to mid-career family physicians and primary care scientists with a structured opportunity to contribute directly to the nation’s most influential health policy body. Fellows continue their academic or clinical work while devoting 10–20% of their time over two years to health- and medicine-related work of the NAM and/or the National Academies of Sciences, Engineering, and Medicine (National Academies), where they participate in research, convenings, and evidence-based policy report development. In this role, fellows are immersed in the national health policy environment—engaging with legislators, agency leaders, scientists, and NAM members—and contribute to projects that shape the future of health care delivery, equity, and population well-being in the United States.

Embedding family physician-leaders at the NAM and the broader National Academies helps ensure that the perspectives of community- and patient-centered care shape high-level decision-making, thereby advancing stronger primary care and a more equitable, sustainable health system.

The Puffer/ABFM Fellowship’s goals are to:

- Introduce fellows to the policymaking process through mentorship and hands-on participation in health- and medicine-related activities of the NAM and the National Academies;
- Cultivate leadership skills and policy literacy grounded in family medicine’s core commitment to community, equity, and patient-centered care; and
- Strengthen the bridge between clinical expertise and national health system reform by embedding family physicians within the NAM’s analytic and advisory infrastructure.

Since its inception, the Puffer/ABFM Fellowship has grown from a pioneering initiative into a cornerstone of ABFM’s broader Leadership and Scholarship Development portfolio, which also includes the Pisacano Leadership Foundation, the ABFM Visiting Scholars Program, and the CPV-GWU Health Policy Fellowship. Together, these programs reflect ABFM’s strategic vision to build leadership capacity within the family medicine workforce and to ensure that the discipline’s voice continues to inform national debates on access, equity, and value in health care. They also reflect ABFM’s enduring belief that leadership and scholarship development are integral responsibilities of a certifying

board—central to preserving, enhancing, and improving family medicine as the “keystone specialty in American medicine.”

Over 15 years, the Puffer/ABFM Fellowship has:

- Doubled in size, expanding its reach and diversity across institutions and professional stages;
- Enhanced orientation and engagement, including joint programming with the Robert Wood Johnson Foundation Health Policy Fellows and other NAM Fellows, and structured mentoring from NAM members;
- Broadened participation across projects within the NAM and the National Academies, ensuring primary care perspectives influence topics from digital health and workforce reform to health equity and public health infrastructure;

→ Created lasting connections among participants that continue to strengthen collaboration between ABFM and NAM; and

→ Resulted in four former fellows being elected to the NAM.

As ABFM celebrates this 15-year milestone, the Puffer/ABFM Fellowship stands as a testament to the specialty’s leadership in health system transformation. By embedding family physicians and primary care researchers within the highest echelons of national policy, the Puffer/ABFM Fellowship strengthens the profession’s capacity to translate practice-based insight into sustainable health reforms that advance equity, value, and the well-being of all communities.

James C. Puffer, MD is currently a Professor Emeritus of Clinical Family Medicine in the Division of Sports Medicine at the David Geffen School of Medicine at UCLA. He served as President and Chief Executive Officer of the American Board of Family Medicine (ABFM), located in Lexington, Kentucky, from 2003-2018. Dr. Puffer is an internationally recognized expert in sports medicine, having served as Team Physician for the 1984 United States Winter Olympic Team and Head Team Physician for the 1988 United States Summer Olympic Team. He served as Team Physician for the UCLA Department of Intercollegiate Athletics for over twenty years before assuming his position at the ABFM, and has subsequently returned to UCLA on faculty recall status where he has resumed responsibilities as a team physician in the Department of Intercollegiate Athletics.

NAM FELLOWSHIPS & WHAT THEY MEAN TO THE NAM

Founded in 1970 as the Institute of Medicine (IOM), the National Academy of Medicine (NAM) provides a vital public service by working outside the framework of government to ensure scientifically informed analysis and independent guidance for policy makers, academic leaders, health care administrators, and the public. It is committed to nonpartisan, evidence-based leadership that aims to advance science, inform policy, and catalyze action to achieve optimal health for all. As such, the NAM created the Anniversary Fellows Program in 2006 to celebrate the 35th anniversary of its establishment and further its commitment to building leadership capacity across disciplines and specialties.

The Anniversary Fellows Program has since become the NAM Fellowships and now comprises 10 distinct opportunities across diverse areas of focus, including family medicine through the Puffer Fellowship. These unique opportunities immerse early-career investigators in consensus building and interdisciplinary policy development, while exposing them to the social, economic, and political forces that affect and shape health status and health care delivery in the nation. These opportunities also help to build a network of mentors for the fellows to gain first-hand knowledge of the

importance of studying health care challenges from a range of disciplines and viewpoints to develop sound strategies.

“We have long viewed the NAM Fellowships as essential in building a pipeline of future leaders who are trained in bridging science with policy,” said the NAM President Victor J. Dzau. “There is a great need to foster the next generation of health science leaders, now more than ever. And the Puffer/ABFM Fellowship in particular is vital in bringing the voice of primary care and family medicine directly into our work so that our perspectives continue to be grounded in community-based, whole-person care to help shape policies that truly improve health for all.”

Over time, creating a cadre of health science scholars who have analytical skills in matters of public policy formulation, legislation and implementation, who have researched and analyzed current health policy issues, and who have worked with leaders in health care policy development will have a significant impact on the nation’s capacity to more effectively meet the health needs of all. And the Puffer/ABFM Fellowship will continue to expand the reach of family medicine within national policy conversations and contribute to the NAM’s mission to improve health for everyone, *everywhere*.

Dr. Tammy Chang is an associate professor in the Department of Family Medicine, a health services researcher, and a practicing family physician with a passion for adolescent health. She is specifically interested in helping break the cycle of poverty and poor health among adolescent mothers and their children via community-engaged research. Her NIH-sponsored research is focused on improving access to reproductive health care and promoting healthy pregnancy weight gain among at-risk adolescents by utilizing text messaging.

She is also the founding director of MyVoice www.hearmyvoicenow.org, a national text-message poll of youth age 14-24 years. MyVoice engages youth and communities typically invisible to researchers and uses mixed methods to inform local and national policies in real-time.

Dr. Chang is also the director of the Health Behavior Optimization for Michigan (HBOM) Collaborative Quality Initiative, a statewide clinical quality improvement initiative with funding and support from Blue Cross Blue Shield of Michigan (U-M). Through her leadership, HBOM uses cutting-edge behavior change strategies to transform clinical practices and priorities. HBOM initiatives help individuals living in Michigan make easier health choices so that all residents can achieve their health and wellness goals.

Additionally, Dr. Chang is the director of the National Clinician Scholars Program at U-M where she trains junior faculty clinicians in health services research. She also teaches a Master’s level course in Leadership and Communication. She actively mentors numerous students in high school, undergraduate and graduate schools, as well as medical students and post-doctoral fellows, to inspire and guide the health services researchers of the future.

Besides her teaching and research endeavors, Dr. Chang is a practicing physician at the Corner Health Center in Ypsilanti.

THE FELLOWSHIP EXPERIENCE... IN THEIR WORDS:

During the initial years of the Puffer/ABFM Fellowship, the program offered little to no structure as it was being designed so that each fellow can maximize the program's flexibility to meet their individual needs. Based on the input from alumni, however, the Fellowship has developed a more structured onboarding process in recent years. All incoming NAM Fellows are now invited to a virtual introduction meeting after the press release announcing a new cohort of fellows is issued. A three-day orientation is also held in September for all incoming NAM Fellows, including the Puffer/ABFM Fellows, to learn more about the NAM and the National Academies, their current/ongoing projects and projects in development. The orientation also offers various networking opportunities with the NAM leadership, NAM Members, program sponsors, and other NAM program participants, including the Robert Wood Johnson Foundation Health Policy Fellows. Each fellow now has a monthly check-in

with the program director to discuss their fellowship activities, identify any issues to mitigate, and touch base on various other issues. Additional new networking opportunities with NAM members are now available as well, such as a networking breakfast for all current fellows and scholars prior to the scientific symposium of the NAM Annual Meeting. Finally, travel funding is provided for all current fellows and scholars to attend the Richard and Hinda Rosenthal Emerging Leaders Forum, an annual invitation-only event that brings together the NAM Emerging Leaders in Health and Medicine Scholars, the NAM Fellows and Scholars, the NAM members, and invited guests across all fields of health and medicine and related fields for crosscutting panels and interactive discussions.

In reflecting on their experience, current and former Puffer Fellows share how the program supported them personally and professionally.

Providing a Welcoming, Inspiring Community

The Fellowship creates an intentional, nurturing community that connects fellows with leaders who model values-driven primary care scholarship and provide ongoing encouragement at critical moments in their careers.

“To be surrounded by family physicians I admire... gave me the personal momentum to feel encouraged to continue my work... It made me feel part of a broader community in a way that was very sustaining.”

Career-Shaping Exposure to Policy and Systems Thinking

Fellows noted the transformative power of being embedded in NAM’s analytic and consensus processes, and how the Fellowship shifts their lens from individual clinical work to the systems-level levers that influence population health and national reform.

“The Puffer Fellowship has shaped my career to be more policy focused and has made me consider implementation, policy and practical implications in all my clinical and research work.”

“I also was able to have meetings with leaders in my field and participate in NASEM roundtables. These activities all dramatically expanded my professional network, and they also gave me insights into the policymaking and evidence-generating process, informing my current research.”

Building Powerful and Lasting Professional Networks

Fellows report forging a diverse, cross-generational network of policy-minded leaders whose shared mission and complementary expertise amplify each other's impact long after the fellowship period ends.

"Learning from past fellows helps me make the most of my current time. By bringing together such a stellar cadre of individuals with aligned interests but broad and varied networks, the opportunities to help each other further our own work toward goals is immense."

Long-Term Engagement and Leadership within the National Academies

Many fellows remain deeply involved in the Academies, taking on leadership roles that shape committees, methodologies, and content, extending the influence of family medicine in NAM's work.

Increased Visibility and Expanded Career Opportunities

Fellows repeatedly noted how NAM engagement had elevated their visibility, expanded their scholarly reach, and opened new doors, positioning them for influential roles at leading academic institutions and in national policy arenas.

Contributions to the National Academy of Medicine

Puffer Fellows have served as active contributors to NAM committees, roundtables, and reports that have shaped the national health agenda and elevated the voice of our discipline. Fellows are not only at the table, but active contributors to written and oral communications in these efforts, which include, but are not limited to:

- Implementing High-Quality Primary Care (2021)
- Future Directions for the Public Health Workforce
- Artificial Intelligence in Health, Health Care, and Biomedical Research
- Social Drivers of Health and Equity in Health Systems
- Primary Care Investment and Financing Reform
- Standing Committee on Primary Care

Through these efforts, Fellows have introduced real-world perspectives from family medicine and community practice into federal and multi-sector policymaking. Their participation has strengthened NAM's work on integrating clinical care and public health, ensuring that patient-centered values remain at the heart of U.S. health reform.

Policy and Leadership Outcomes

- Fellows have influenced policy at federal and state levels through service on NAM committees, advisory councils, and public health boards.
- Many have continued NAM involvement as committee members or reviewers.
- The Fellowship has seeded collaboration between ABFM and NAM on subsequent primary care and workforce initiatives.

NAM Annual Symposium activities. Fellows also participated in a career development seminar with 7 senior Family Medicine leaders, sharing an array of backgrounds and experiences and lessons from their journeys with the Puffer cohort, engaging in individual mentorship, and building new connections.

The meeting also saw 2014-16 Puffer Fellow Dr. Kendall Campbell celebrated by the NAM as a newly elected member of the National Academy of Medicine.
